	f working from an alternate location, employee must be available for daily updates by phone or email on their day off campus.
	Employee is responsible for providing their own home computer and any necessary technology such as a broadband nternet connection.
	Employee will keep record of work accomplished as outlined by their supervisor when at the alternate work place. All College policies, including paid leave policies, will apply to any employee on an alternative work arrangement.
